The Board then considered the minutes from the June 13, 2023, board meeting. A motion to approve the minutes was made by Tracy Brown and seconded by Stephen Jones. The minutes were approved (9-0-0) and a copy of the voting record is attached as Exhibit "B".

Next, the Board considered an ENS request from Owen County. Mark Myers made a motion to approve the request and Brad Meixell seconded. The ENS request was approved (9-0-0) and a copy of the voting record is attached as Exhibit "B".

Delvan Roehling then presented the financial report for the period ending June 30, 2023. This financial report will remain marked "draft" until the completion of the audit.

During the legal update, the Board attorney Lauren Box, shared that contracts were awarded to AT&T and INdigital and the contracts will be ready for the Board to approve at the December board meeting.

Craig Bennett with AT&T then presented the AT&T ESInet update for the state of Indiana. Shane Rekeweg from INdigital followed with an update on the network operations for the first quarter of 2023. Finally, Joel McCamley, ENP, with 911 Authority gave an update on the 911 network for the state of Indiana as well as the Cyber Security Assessment progress.

Barry Ritter with Ritter Strategic Services then gave an update on the progress of the CAD2CAD Data Survey Project and the Legacy charges concerning Frontier....

- Washington Co: Tammy Shanks retired after 20 years of service as a dispatcher.
- Henry Co: Sha Kirk assisted a caller whose vehicle was sinking in a pond and empowered her to find a way out which the caller did safely.
- Spencer Co: Lara Hancock helped deliver a baby girl over 911.
- ISP: Remembered Trooper Aaron Smith who lost his life in the line of duty. EOW: 6/28/23

In other business, Stephen Jones reminded the Board to be aware of the upcoming eclipse on April 8, 2024 and the impact it will have on public safety. Craig Bennett with AT&T stated that several AT&T PSAPs have already reached out and are planning on utilizing 311 to help with the anticipated calls.
